# **Medical Club Bylaws:**

**Article I. Medical Club** 

I.Medical Club is a MHS CLUB, hereafter referred to as Medical Club.

# Article II. Purpose of the Club

### **Article III. Membership**

I.Membership is open to any currently enrolled Mundelein High School student interested in obtaining a profession in the medical field in the future.

II.Only students who have been in the club a minimum of one year are allowed to run for club offices.

III.Current members may bring up new concerns or ideas during the open floor session of regularly scheduled meetings.

## **Article IV. Officer Positions**

I.The officers of this club shall all maintain equal status as co-leaders.

II.Officers will be elected for one year by a vote of the club at the end of each school year. During first year, active leaders will seek new leaders for the following year. These new leaders will apply and be voted upon at the end of the year.

III.Officers cannot miss more than one meeting per month.

### **Article VI. Faculty Sponsors**

II.At least one sponsor must be present at all club meetings and events.

III. The sponsor will be responsible for supervising elections and maintaining order within the club.
